**2. NOTICES TO COMPETITORS**

**5. SCHEDULE OF RACES**

- 5.1 Dates of Racing: Saturday April 17-18, 2021.
- 5.2 Three races are scheduled. One completed race will constitute a regatta.
- 5.3 Scheduled time of the warning signal for the first race each day is 1155 PM.
- 5.4 Skippers Meeting at the Oar House, 1000 S. Pace Blvd at 1800, Thursday, April 15.

**6. CLASS FLAGS**

Spinnaker	Pink
Multi-Hull	Purple
Non-Spinnaker	Light Blue

**8. THE COURSES**

The courses to be sailed will be posted on the signal vessel.

**9. MARKS**

- 9.1 The starting mark will be an Orange Tetrahedron and an Orange Flag on the signal vessel.
- 9.2 The finishing mark will be a Blue Flag on the signal vessel and a course side marker.
- 9.3 For L, W and T courses, Mark A (windward) and Mark C (leeward) will be orange tetrahedrons. Replacement marks will be yellow tetrahedrons and/or posted government marks.

**11. THE START**

- 11.1 The starting line will be between the Orange Flag and the course-side of the Orange Tetrahedron with the appropriate class flag (s).
- 11.2 A boat failing to check in properly will be so notified of its failure by the RC and will be scored a penalty of 20% without a hearing. This changes RRS 63.1 and A5.

**13. THE FINISH**

The finishing line will be between a blue flag on the signal vessel and the course-side of a red marker.

**15. TIME LIMITS** (Spinnaker and Multi-Hull Divisions only, for L, W and T courses)

15.1 Time limits are as follows:

Mark A	45 minutes	Time limit for the first boat to pass Mark A.
Race	2.5 hours	Time limit for the first boat to sail the course and finish.

Finishing Window 45 minutes Time limit for boats to finish after the first boat finishes.

**15.2** If no boat has passed Mark A within the Mark A time limit, the race shall be abandoned. Failure to meet the target time will not be grounds for redress. This changes RRS 62.1(a).

**15.3** If no boat has sailed the course and finished within the race time limit, the race shall be abandoned. Failure to meet the time limit will not be grounds for redress. This changes RRS 62.1(a).

**15.4** Boats failing to finish within the finishing window shall be scored Did Not Finish (DNF) without a hearing. This changes RRS 35, A4, and A5.

## **21. PRIZES**

**21.1** Prizes will be given for this regatta as follows:

Spinnaker Divisions: 1<sup>st</sup> – 3<sup>rd</sup> place.

Multi-Hull Divisions: 1<sup>st</sup> - 3<sup>rd</sup> place

Non-Spinnaker Divisions: 1<sup>st</sup> – 3<sup>rd</sup> place.
